Residential Snow Plowing Contract – PER TIME

### Category A Snowfall

1.00" – 2.99" of snow ----- \$ \_\_\_\_\_ .00 / Snow Event  
C N'R will clear snow off of driveway(s) only 1 time after the snow has finished accumulating.

### Category B Snowfall

3.00" – 5.99" of snow ----- \$ \_\_\_\_\_ .00 / Snow Event  
C N'R will clear snow off of driveway(s) 1-2 times during the snow event. If the snow event requires 2 clearings, the first clearing will be an "opening" and the second clearing will be a complete plow. No matter how many times C N'R clears the driveway, the amount stated is the total price for that snow event.

### Category C Snowfall

6.00" – 9.99" of snow ----- \$ \_\_\_\_\_ .00 / Snow Event  
C N'R will clear snow off of driveway(s) 1-3 times during the snow event. Until the final clearing is accomplished, all clearings prior will be "openings" of the driveway(s). No matter how many times C N'R clears the driveway(s), the amount stated is the total price for that snow event.

### Category D Snowfall

10.00" – 13.99" of snow ----- \$ \_\_\_\_\_ .00 / Snow Event  
C N'R will clear snow off of driveway(s) 2-3 times during the snow event. Until the final clearing is accomplished, all clearings prior will be "openings" of the driveway(s). No matter how many times C N'R clears the driveway(s), the amount stated is the total price for that snow event.

### Category E Snowfall

14.00" + of snow ----- \$ \_\_\_\_\_ .00 / Snow Event  
C N'R will clear the snow off of driveway(s) 2-4 times during the snow event. Until the final clearing is accomplished, all clearings prior will be "openings" of the driveway(s). No matter how many times C N'R clears the driveway(s), the amount stated is the total price for that snow event.

**Definition:** "openings" = clearing a path from the road to the garage that may not be the total width of the driveway(s). This is to ensure that customers can at least get in and out of their driveway(s) for the duration of the snow event.

**End of Driveway Clearing** ----- \$ \_\_\_\_\_ .00 / Snow Event  
This charge will be initiated per snow event and will guarantee that the end of the driveway(s) will be cleared whether the city plow arrives before or after C N'R

**Driveway Straight Salt (effective to -15°)** ----- **\$ 44.00** / Event  
C N'R will apply SALT for most plow-able snowfalls, for most snowfalls under 1 (one) inch, and for most freezing (or re-freeze) precipitation that occurs. **\*\* \$0.50 per pound of salt applied will be added to the total base price stated above \*\***

Any month (5 total) without plowing, a **MINIMUM RETAINER** fee will be charged equal to a 'Category C' snow event.

The terms are net **30 days**. A late payment fee of 21% APR is assessed after 30 days. Finance charges are assessed for each 30-day period without full payment of an invoice. Upon selling the home/property, this contract can be terminated on the date of "closing". Fuel surcharges of 2.0% of the total invoice is added each month that fuel prices go above \$2.50/gallon, with an additional 0.5% for each \$0.25 thereafter. By signing this contract, I agree to; personally guarantee payment; understand the charges of all checked off services; I have read the corresponding specifications sheet; I understand all "costs for collections" are recoverable as part of a judgement.
