This includes shrubs/perennials/annuals that are not surrounded by landscape. If the grass is growing at a pace that is not manageable within a week's time, double cutting on the same visit may be necessary. Extra charges will be assessed accordingly for these situations equal to no more than half the "weekly mow price".
